What is the Standard?

The Quality in Careers Standard is **the** single national quality award for careers education, information, advice and guidance (CEIAG) in secondary schools, colleges and work-based learning.

It's a sector-led development to support continuous improvement and celebrate excellence in careers work. First developed over thirty years ago, through a network of locally accredited schemes, we now have a single national quality award. The Standard is owned by the Quality in Careers Consortium, comprising the four major professional associations of school and college leaders - Association of Colleges, Association of School and College Leaders, National Association of Head Teachers, Sixth Form Colleges Association- alongside the Career Development Institute and Careers England. The Consortium Board oversees the currency and rigour of the Standard and delivery through the licensing of Awarding Bodies.

How does it support improvement and impact?

The eight Gatsby Benchmarks are at the centre of the Standard with additional evidence required of impact upon students' career-related learning to assure provision. The DfE 'strongly recommends' in its Statutory Guidance that all schools and colleges should achieve the Quality in Careers Standard because of the proven correlation between making better progress on Gatsby Benchmarks and possession of Quality in Careers Standard. It's also recognised that the Standard provides:-

- >>>> A structured framework to develop a strong and sustainable provision in line with Ofsted and ISI requirements
- >>>> Access to expert advice from a careers professional to investigate existing provision and give confidence on what works well and areas to develop
- >>>> Strengthening of whole school or college commitment
- >>>> Systematic review of the evidence of impact of the careers programme through portfolio assessment and on-site assessment
- >>>> A strong process of continuous improvement through clear recommendations and reaccreditation
- >>>> Professional development for school/college staff (alongside the Careers Leader programme)

As leaders, we are ensuring that our students are offered the knowledge, skills and understanding to continue to develop their Careers into adulthood and beyond. Use the national Quality in Careers Standard as a development tool, not simply an award, and it will help you to make sure that you and team offer every student the best bespoke opportunities as possible. 
As leaders, we are ensuring that our students are offered the knowledge, skills and understanding to continue to develop their Careers into adulthood and beyond.

How does the Standard work alongside developments?

The Standard is available to schools and colleges across the United Kingdom and builds upon other resources including self-assessment and peer support. The Quality in Careers Standard is the only Award that is externally assessed against robust national criteria and accredits best practice.

The development journey towards achieving the Standard involves:-

- >>>> an in-depth audit of your careers programme following completion of the Compass self-assessment tool
- >>>> advice and support available on developing your provision from a 'consultant' or 'mentor'
- >>>> consultation/discussions with key stakeholders in your school or college including staff, parents and young people
- >>>> an external assessment by an independent Quality in Careers assessor who has not been involved previously in the process.
